

## Scratch and Win Official Rules

1) Game piece is packed in specially marked boxes of Jet KW1+, SC1, M1 and WR5 - 250-pack keys. Complete list of rules and regulations of the sweepstakes are available at [www.jetkeys.com](http://www.jetkeys.com).

Game begins at **12:00 a.m.** Eastern Time on **07/01/2009** and ends at **11:59 p.m.** Eastern Time on **09/30/2009**, or upon distribution of all game pieces, whichever occurs first and is open to legal residents of the US. Entrants must be 18 years of age or over on or before **07/01/2009**.
